

PHIT America Privacy Policy

Protecting your private information is our priority. This Statement of Privacy sets out how PHIT America uses and protects any information that you give PHIT America when you use this website. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

PHIT America may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from January 1, 2020.

Collection of your Personal Information

In order to better provide you with programs and services offered on our site, PHIT America may collect the following information such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to use when you elect to use certain programs or services available on the Site. These may include: (a) sending us an email message; (b) applying for AMPED; (c) applying for EZ Pass program, (d) information on the Every Kid Sports Pass Program. We will use your information for, but not limited to, communicating with you in relation to services and/or programs you have requested from us; approving you for receiving services.

Use of Personal Information

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by PHIT America. How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyze web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyze data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

SSL Protocol
